Notes: A survey from 1988 (Liber 4554, folio 101), a land record from 1987 (Liber 490, folio 465), mention of a cemetery in an unknown record book, Book 4790, p. 465-469 circa 25 September 1987; and a reference to a land record from July 1977 (Liber W.C.L. 2984, folio 104) are also on file. Thomas H. Langley and Delbert C. Langley both formerly owned the property. Information was provided by Lawrence (Paul) Wiseman, a descendant who lived nearby and William H. Langville, III. The name "Langville" became "Langley" and then was changed back to "Langville" (by Tom himself). The owner from 1990-2021, Nishan Topjian, was taken to court over refusal to grant a right-of-way to the cemetery. He also threw some of the tombstones down the hill according to Mr. Wiseman. The property was sold to Michael Replogle in May 2021. It is now under the stewardship of the Langley Cemetery Association, Inc., a Maryland non-stock, non-membership corporation that is applying for IRS non-profit status.
